DEEP BLUE SYNC (extra)

Possibility for each Yacht of the Fleet to be equipped with a Deep Blue License on a Local Server (Mac Mini server) .

Crew members can work off-line when on-board the Yacht, Local Server will automatically synchronises with Master server when Internet connection is available.



SAVE TIME

- Access all Yachts database from 1 unique custom Interface from any device: PC, Mac, Tablet, Mobile.
- Give custom access to unlimited users to each Yacht Account based on users' position and permissions.
- All Yachts valuable info & alerts can be Seen through a user friendly Fleet Dash Board and then Yacht Dash board.
- Give or Receive validation from Owner, Captains directly through the interface avoiding emails & phone calls.
- Allow Crewmembers to enter their own expenses in real time with receipts / invoices attached.
- Edit detailed analytical Financial reports for selected accounts or consolidated, in different currencies, in just 1 click.

BE ORGANIZED

- Define custom permissions for each users with access to the Yacht account (Crew, Owners, Managers) based on users position and define custom permissions.
- Define which User on each Yacht has access to "Accounting", Activate multiple Yacht and Crew bank accounts, activate Cash & Debit Card accounts for Crew.
- Customize Charts of accounts and edit Yearly Budgets involving different Users, generate Pdf / XLS for validation with Owner.
- Classify all Crew and Yacht documents under International Standards, make settings at Fleet Level. Define mandatory Crew documents for each Yacht.
- Generate analytical pre-formatted Financial Reports per bank account or consolidated in different currencies with custom exchange rate system, Compare expenses validated Budgets, and control respect of.
- Find all HRM reports from Crew. Monthly works Hrs/Rest Leave/Duty/Rest days summary, generate monthly Pay Rolls.
- Edit Yacht, Crew and Document Events in a shared calendar with Management and Owner.



MANAGE-IT

- Use one corporate interface to control a Fleet of Yachts staying at Fleet Level or zooming in one single Yacht. See statistics for Fleet.
- Give approvals to Quotes and Invoices through a shared accounting module. Control strict respect of approval procedures through users logs.
- Generate analytical pre-formatted Financial Reports for Owners & Owner Reps with comparison to validated Budgets for monthly or yearly periods.
- Control on a Yacht basis respect of on-board working rules (MLC). Edit Crew individual declarations for Work & Rest hrs, see Leave & Duty recap, edit monthly Pay Rolls.
- Control expiration dates of 100's of Crew & Yacht certificates. Be alarmed on Yachts not complying to safe manning rules.
- Validate Maintenance program for the Yacht with chief of departments (Chief Engineer, Chief Hostess...), edit Crew monthly work reports.
